5. Electronic bids must be submitted to the Varagung Mukti Chhetra Rural Municipality, Office of the Rural Municipal Executive, Kagbeni through PPMO website on **2077/07/06 12:00 HRs (Oct 22nd, 2020)**. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs. **And 2077/07/06 (Oct 22nd, 2020)** at the office of Varagung Mukti Chhetra Rural Municipality, Office of the Rural Municipal Executive, Kagbeni. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, mentioned above bid Security Separately, which shall be valid for 30 days beyond the validity period of the bid.
